7. REPORT OF CLOSED SESSION ACTIONS

Board President Don Lee read the following statement: "In closed session, the Board approved payment of two offers to compromise in the case of Jane RR Doe, et al. v. Torrance Unified School District et al., Los Angeles Superior Court case number BC 678860."

He then continued with the following: "The Board of Education at its meeting of May 6, 2019, in Closed Session, took action to accept the resignation of Certificated Employee Case #01-18/19 from employment with the Torrance Unified School District effective at the end of the workday on September 5, 2019." The roll call vote was as follows: Ayes: 5, Noes: 0, Absent: 0, Abstain: 0.

8. STAFF PRESENTATION AND INFORMATION

Information: 8.1 Report by Student Representative

Mr. Ben Egan introduced the Student Representative from North High School. She stated that North High had a very successful Golden Bear Competition put on by the JROTC. They also sponsored a campus beautification event. The Relay for Life team from North High raised over \$8,000 for cancer research. The NHS Boys Volleyball team was celebrated for making it to the first round of CIF and the Track Team for making it to the CIF Finals. They are working with the new ASB advisor and student council members to prepare for next year. Students will be voting for top 15 soon, and are also in the middle of preparing for the upcoming AP testing.

Information: 8.2 Good News Student Presentations from Carr Elementary School and Casimir Middle SchoolDr. E Don Kim introduced the student representative from Carr Elementary School, along with principal Katie Schenkelberg. The student representative talked to the Board about the Carr Cub powerpaper, which is run by the 5th graders. They report stories

student representative talked to the Board about the Carr Cub newspaper, which is run by the 5th graders. They report stories from all around the school. They also do interviews, like a recent one done with Mayor Furey when he visited the Carr campus. They also have special announcements on Wednesdays to give students additional information about things happening on campus.

Mr. Egan introduced three student leaders from Casimir Middle School, along with principal Susie Holmes, and teacher Ms. Moretti. The girls each talked about different aspects of the computer class and club offered at Casimir. They mentioned that students can be involved in several computer related activities, such as web design. There is also a cyber security club, where

they look at various aspects of security, along with learning how to check for hidden files, etc. Students also have the opportunity to compete in cyber competitions. They recently competed in the Cyber Cup in Long Beach, where the Casimir girls team took 2nd place and the Casimir boys team took 3rd place.

9. ORAL COMMUNICATIONS (UNSCHEDULED HEARINGS): Non-Agenda Items

Information: 9.1 The Board of Education welcomes input from the public. In order to discuss District business in an orderly manner, for the privacy and safety of the speakers, and to help staff respond more directly, the Board Policies require that public presentations to the Board comply with certain procedures, including: Speakers to non-agenda items may address only items that are within the subject matter jurisdiction of the Board. Time allotted for such presentations is limited to 3 minutes. Total time allotted for public input on non-agenda items is limited to 30 minutes. A speaker may not relinquish her/his time to another. When addressing the Board, speakers are requested to state their name, address the President from the podium, and adhere to the applicable time limits. Complaints against employees or students will normally be heard in Closed Session and the District's complaint procedure should be followed before discussion with the Board. The Board may remove disruptive individuals and order the room cleared if necessary. Any person who willfully disturbs any public school meeting is guilty of a misdemeanor (E.C. 32210).

Sandy Hutchinson, teacher at Seaside, wanted to thank the Board members for accepting her previous invitation to visit Seaside, talk with teachers, and see what is taking place on their campus. She also informed everyone about a very informative program called Screen Time which gives insight into how much time kids actually spend looking at different screens, rather than spending time with people.

A student from North High School addressed the Board and expressed his concerns over the lack of funding for Arts programs in TUSD including band, dance, music, ceramics, etc. He feels more attention should be given to the arts which provides students a creative way to express their emotions and feelings. There needs to be more of a balance between test scores and creativity.

Another student from North High School addressed the Board with his concern that there was no AED (Automated External Defibrillator) on site at the Aquatic Center. Dr. Stowe was checking with the Aquatic Center Manager, and if there is not one on site, they will get one.

Denise Miller, teacher at Casimir Middle School, expressed her concern over the recent Social Science textbook adoption under the assumption that workbooks/notebooks were included with the textbooks, only to find out that they are not. Teachers were told that the workbook is available online, which is a problem for many reasons. Some of the issues are as follows: not all students have internet access at home, computer labs/chromebooks are not always available on campus for every student, it would take teachers a lot of time to make copies of workbook pages, along with using a lot of paper, some sites do not have the funds to purchase the workbooks, which then does not give equal access to all district students, etc. President Lee stated that the Board is aware of this issue and there has been discussion already on the subject. He said Mr. Egan would be available to talk with teachers about possible solutions.

Deb Tabush, teacher at Riviera Elementary, stated that she was part of the Social Science textbook adoption committee and reiterated Denise Miller's concern over the misinformation that was given regarding inclusion of workbooks. She wanted to make sure that this issue is looked into for the long term so in the future everyone is given the same information and that all committee members are included in the conversation.

Kurt Burgner, from Magruder, also expressed concern over the misunderstandings regarding the supplemental materials and that teachers accepted the TCI curriculum with the understanding that workbooks were included. He reiterated the problems with not all students having internet access at home, limited access to computer labs and chromebooks at school, and lack of site funds to purchase workbooks. President Lee stated again that Mr. Egan is prepared to discuss the matter with teachers at their convenience.
